SEPARATE SIGNATURE AND ACKNOWLEDGMENT PAGES FOLLOW

**This agreement shall be in force from the date signed and for all visits thereafter to Dog-Gone Fun, Inc., hereafter referred to as DGF.** I hereby certify that my dog(s) is/are in good health and have not been ill with any communicable disease in the last 30 days; and that my dog(s) has/have current vaccines for rabies, distemper, parvovirus, parainfluenza, hepatitis, and bordatella. I further certify that my dog(s) has/have not harmed or shown aggression or threatening behavior towards any person or any other dog, except as disclosed in writing to DGF. I give authorization to DGF to speak to my veterinarian and/or their staff to confine my dog(s) vaccine status, and medical history.

**I have read and understand the following:**

- I. DGF and their staff shall not be liable for any injury or damage to any person or persons, animals, or to any property, however caused, which result from the training, behavior, care or grooming of my pet, as well as from any negligence on the part of any other pet owner attending DGF. I further agree that DGF shall not be liable for any costs, attorneys' fees or expenses incurred in connection with any claim, action or proceeding occurring as a result of my pet's participation at DGF.
- II. I am solely responsible for any harm and/or damage caused by my dog(s) to persons, property or other pets, while my dog(s) is/are attending DGF and I agree to protect and indemnify DGF against related costs or expenses. DGF reserves the right to refuse services or admittance to any dog. Costs for repairs to property will be my sole responsibility.
- III. I understand there are inherent risks associated with the presence of dogs in training, whether group or private sessions. I assume full responsibility for myself, my dog, any substitute handlers of my dog, and any observers that attend class with me. I agree that I have given full disclosure of any history of aggressive behavior by my dog, and understand that failure to do so will result in my dismissal from classes and no refund shall be given.
- IV. I agree that the trainer and DGF will not be liable for any damage or loss resulting from the failure of my dog to respond to any commands taught to my dog or resulting from counseling and advice supplied to me. My dog's behavior now and in the future is solely my responsibility. Should any behavior on the dog's part now or in the future result in damage to the property, or person of a third party, I agree to assume full liability for any and all such damage, and to absolve the trainer and DGF from any and all obligations to pay such damage.
- V. I agree that my dog(s) may be videotaped, photographed and/or recorded

by any medium, without compensation to me, and that DGF shall have the exclusive ownership and copyright in all resulting videotapes, photographs, recordings or other materials, and all related rights.

VI. I understand that this program may be offered through Kernersville Parks and Recreation Department. If applicable, in consideration of my dog(s) participation in the aforementioned Kernersville Parks and Recreation program or activity (including traveling), I hereby discharge and release the City of Kernersville, the Parks and Recreation Department, and any and all employees or the agents thereof, from all claims of any kind or nature whatsoever arising out of the actions of the above said employees or agents to the extent allowed by law.

VII. I understand that DGF offers dog training services through an independent contractor, which includes obedience training and dog behavior consulting services ("Obedience Training"). The Obedience Training is an optional service conducted by an independent contractor pursuant to a separate agreement, a copy of which is attached hereto as **Exhibit A**. If I choose to enroll my dog(s) in Obedience Training, I hereby discharge and release DGF and any and all employees or the agents thereof, from all claims of any kind or nature whatsoever arising out of the actions of the aforementioned independent contractor or its agents to the extent allowed by law.
